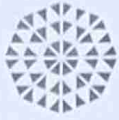

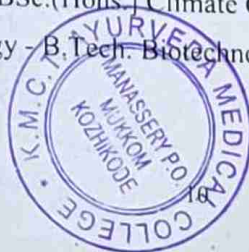

- 4.1.3 **Reservation for Persons with Disabilities:** Leaving the seats set apart under Clauses 4.1.1, 4.1.2 above, all types of supernumerary seats sanctioned, five percent of the seats available for the state for allotment from the Entrance rank lists for all the courses in all the Government Colleges, Aided colleges and Government Cost-sharing Engineering Colleges are reserved for the candidates with Benchmark disabilities.
